Notification of Road Closure - A523 Bonis Hall Lane Junction

As the Principal Contractor working with Cheshire East Council to deliver the Poynton Relief Road project and the A523 Bonis Hall Lane junction improvement scheme, we would like to inform you we will be imposing a closure of Bonis Hall Lane at its junction with the A523 London Road.

The closure will enable us to complete the installation of new permanent traffic light signals, final surfacing and white lining works. These works are essential to complete the junction improvement, which will improve safety and traffic flow when completed.

IMPORTANT INFORMATION ABOUT ROAD CLOSURE

The 24-hour a day closure will take place from **Friday 18th March** until **Friday 8th April**.

We are aware of the effect traffic disruption has on our neighbours and the local community and will only be imposing the closure for as long as is necessary. A signed diversion route will be in place for the duration of the closure.
